

THE BURDINE LODGE RESTORATION

Methodists have been offered a significant opportunity to share in celebrating the influential role of early Methodism in South Carolina and to honor the work of Francis Asbury, the pioneering bishop of American Methodism. The Pickens County Cultural Commission has acquired by donation for reconstruction and restoration a two story log house known as “The Burdine Lodge”.



Built in the 1760's, the house was moved in the 1790's to Old Vinland School Road in the Dacusville Community of what was known as the Pendleton District. In 1796 the house became home to Samuel Burdine, an early Methodist in the area, and a lodging place for Bishop Francis Asbury when traveling from North Carolina into South Carolina through the Saluda Pass. In his journal Asbury documented visits with Samuel Burdine in November, 1800, accompanied by Bishop Richard Whatcoat, and again in November, 1802. The Burdine home also became a meeting place for a Methodist Society.

The Pickens County Cultural Commission has plans to add The Burdine Lodge to other historical structures at the Hagood Mill Historic Site as a tribute to the pioneering work of Bishop Francis Asbury and the influence of early Methodism in South Carolina. The Lodge has been professionally “deconstructed”, labeled and stored in a county warehouse awaiting restoration when funds permit.

In recent years, from twelve to thirteen thousand people have annually visited the Hagood Mill Historic Site. Those totals are expected to increase to from fifty to sixty thousand annually with the recent opening of the South Carolina Rock Art Center at Hagood Mill. The Rock Art Center celebrates the 2003 discovery of Native American petroglyphs(rock carvings) on a large thirty foot long rock near the Hagood Mill. The seventeen human “stick men” on the Hagood Mill rock are thought to be between 1,000 and 2,000 years old. The South Carolina Rock Art Center at Hagood Mill has been constructed to protect and exhibit the petroglyphs and to feature related exhibits. It is expected that this discovery and exhibition will draw people from all over the United States and beyond.

The reconstructed and restored Burdine Lodge and accompanying Methodist exhibits will join other exhibits at the Hagood Mill Historic Site in bearing witness specifically to the work of early Methodism in upper South Carolina. The cost of this reconstruction and restoration project is estimated to be eighty thousand dollars. As with the deconstruction of the house, the reconstruction and restoration will be done by professionals.

At its meeting on November 9, 2013, the South Carolina Conference Historical Society endorsed The Burdine Lodge as a fundraising project and authorized its officers to seek financial contributions. The Society hopes that you will want to join in supporting this effort through a contribution. It is the Society's hope that Methodists working together will be able to make a significant financial contribution towards this project. Mission. The mission of the South Carolina United Methodist Foundation, Inc., is to cultivate, develop, and administer current and deferred gifts for endowment to support United Methodist institutions, agencies, and local churches, as well as other church-related ministries and charitable purposes and to encourage planned giving among United Methodists in South Carolina.

The General Endowment Fund. The General Endowment Fund is the Foundation's basic support fund. The operating expenses of the Foundation are a first claim against the income of the Foundation's General Endowment. Income after expenses may be distributed at the discretion of the Foundation's Board of Directors to the Institutional Members of the Foundation. The Foundation actively solicits gifts and bequests for its General Endowment. Any gift or bequest to the Foundation which is not designated for the benefit of a specific institution, agency, local church, or other charitable purpose is added to the Foundation's General Endowment.

Designated Endowment Funds. Designated Endowment Funds are Funds owned and administered by the Foundation for the benefit of a designated institution, agency, local church, or other charitable purpose. Designated Funds may be "open" and receive contributions from many donors, or they may be "closed" having been established by the gift of a single donor or family. Restricted Funds may be established by current gifts or they may be established by deferred gifts such as a bequest, a gift annuity, or a distribution from a trust.

Charitable Gift Annuities. The Foundation initiated a charitable remainder gift annuity program in 1981. A gift annuity is a life income charitable gift vehicle which provides a guaranteed income for one or two lives. In exchange for an irrevocable gift to the Foundation of cash or publicly traded securities, the Foundation contracts to make annual payments for life to the donor or other life income beneficiary based on a fixed rate determined by age at the time of the gift.

Assets Under Agreement. Assets administered under agreement are endowment funds placed with the Foundation for administration under the terms of a revocable agreement by local churches, boards, agencies, or other organizations affiliated with the South Carolina Annual Conference of the United Methodist Church. Such organizations become "Agency Members" of the Foundation. Funds placed with the Foundation under this program are commingled with other designated funds of the Foundation for investment purposes.

Self-supporting. The Foundation is self-supporting. Its annual operating costs are funded by income from its General Endowment Funds and Administrative Endowment Fund and from administrative fees charged other funds which are owned or administered by the Foundation. The business, property, and affairs of the Foundation are managed by a Board of Directors composed of the following members:
