### 1 Online Church Plan

**\$1/member per year**

Based on church's average weekly attendance per the Journal.

Perfect for churches that do a weekly or monthly email. We send you a PDF of the Advocate each month and you email it to your congregation.

### 2 Print Church Plan

**\$10 per subscription per year**

Must have 10+ participants for discounted rate of \$10 (regular rate is \$15/year).

Perfect for churches who don't send out regular (or any) emails. Subscriptions are mailed directly to your church member's home.
