

Today's the day: the final book processing event for the Million Book Effort, capping 15 other processing events held across S.C. between Mav 26 and now.

Coming today: Pensions and health proposals

FLORENCE—Some major changes are on the horizon when it comes to pension and health benefits for clergy, retirees and conference staff. That report is scheduled for presentation this afternoon (Tuesday).

Dialogue is intensifying among Annual Conference members about a new plan to switch billing for church costs for their pastor's 2015 insurance from a tiered rate to a uniform rate across all churches—a flat \$823/month cost.

According to the Rev. David Anderson, conference pensions and health benefits officer, the Conference Board of Pensions and Health Benefits believes a uniform rate will make transitions smoother for churches in their budgeting process. Amounts will not fluctuate when pastors move midyear from one church to another.

Additionally, regarding health benefit premiums, the conference will see an increase of 5.5 percent, plus a shift from a five-tier insurance premium to a three-tier one, covering Participant Only (\$225/month cost), Participant Plus One (\$470/month) and Participant Plus Family (\$622/month).

Anderson said the 5.5 percent increase is far less than he expected because of last year's high loss-ratio; claims were extremely high at 120 percent.

"It's very good,"

Anderson said. "I was expecting a 16 percent increase. Instead, we got 5.5 percent."

Finally, regarding pensions, the past service rate will increase 2 percent for clergy who retired with pre-1982 service; they will now get a \$725/year pension payment instead of \$720/year. And when it comes to pension costs, there will be no increase in percentage for full-time or part-time clergy.

These elements are broken into several different reports, found in full in pre-conference materials.

Annual Conference members will have the opportunity this afternoon to vote to agree or amend each report individually.

Body to hear motion on race reconciliation today

Annual Conference members will hear a motion from the floor today designed to foster racial reconciliation among S.C. United Methodist churches.

The Rev. John Culp told the *Daily Advocate* he will present the motion during the Connectional Ministries report to create out of the Emerging Ministry Fund a task force or committee to address racial prejudice and injustice as a "theological and missional imperative" on the local level in congregations and neighborhoods.

The motion asks for up to \$10,000 to create the task force and host two one-day conferences in 2015—one at Wofford College and one at Claflin University. The conferences would address current realities regarding race in S.C. and the U.S.; the role of the church in addressing racism; how clergy can provide leadership in racial reconciliation; and moving beyond integration to reconciliation.

As part of the motion, all clergy

would be strongly urged to attend one or both of the conferences and with at least one layperson from the local church, and each pastor would also report at charge conference what is being done in the local congregation and community toward racial reconciliation and justice, or set specific goals with results to be reported at the 2015 charge conference.

Culp notes in his motion that S.C. has the largest number and percentage of African-American United Methodists and clergy, and while society has made much progress since the merger in 1972, much more needs to be done to provide a prophetic witness to the broader society and to remove existing barriers.

"Racism remains a systemic problem in the church and society, though the manifestations tend to be more subtle," Culp said, noting local churches often remain segregated with little interaction across racial and ethnic boundaries.

AC members will have the chance to vote on the motion this morning.
